If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure, pandemic or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a Prize, subject to State or Territory regulation. For the purposes of these Terms and Conditions, a Force Majeure event includes but is not limited to: severe weather events, natural disasters (such as floods, bushfires, or earthquakes), pandemics, epidemics, government restrictions or regulations, acts of war or terrorism, civil unrest, or any other circumstance beyond the reasonable control of the Promoter that prevents or materially affects the conduct of the Promotion.
