Operational use must meet one or more of the following criteria for an AUA to be approved.

- ☐ Be directly involved with the operations or servicing of aircraft
- ☐ Be directly involved with the servicing of Ground service Equipment (GSE)
- ☐ Be directly involved with the servicing, maintenance or construction of airside infrastructure, aviation equipment, building/s or other aviation facilities, and that these areas cannot be reached via landside
- ☐ Have a need or authority to carry out regulatory or law enforcement activities on the airside

In deciding whether to issue an AUA, CA will consider the following:

- 1) Safety on the airside in relation to aviation operations, persons on the airside and property on the airside
- 2) Congestion of the airside areas, thereby decreasing the efficiency of the airport (particularly ramp areas), and increasing the risk of accident to all users of Cairns Airport.

In making this Application for an Authority for Use Airside (AUA), I acknowledge and agree that:

- I have read and understood the Cairns Airport Airside Vehicle Control Manual (AVCM) in relation to vehicle/equipment requirements;
- It is a condition of an AUA that I comply with the AVCM and the Conditions for Operating Airside;
- Failure by the vehicle to comply with the AVCM or Conditions for Operating Airside may result in the AUA being suspended or withdrawn;
- I will take out and maintain public liability insurance for an amount not less than AUD \$20 million for vehicles accessing Perimeter Roads, Aircraft Stands, Aprons and Manoeuvring Areas when towing aircraft and for vehicles accessing Runways, Taxiways and Aircraft Manoeuvring Areas to conduct airside construction works/repairs:
  - Note the interest of Cairns Airport Pty Ltd;
  - Provide a copy of the certificate of insurance to Cairns Airport with this application;
  - All state registered vehicles are required to have an 'airside endorsement';
  - Provide signed 'Indemnity Agreement' – only one submission required per company;
- I undertake to ensure that the Vehicle is operated in accordance with the AVCM, CASA Civil Aviation Order (CAO20.9);
- It is the vehicle operators responsibility to ensure vehicle/equipment meets applicable industry standards and is maintained in a safe working condition at all times;
- I have read and understood the Privacy Statement included on this Application Form; and
- If I do not pay the application fee of \$30 for the AUA within 30 days of the date of invoice, then the AUA for the vehicle will be suspended immediately.
